

**CHAPTER 3****POLICE REGULATIONS****301. TRAFFIC REGULATIONS**

**Section 301.01. Traffic Regulations.** Minnesota Statutes, Chapters 65B, 168, 169, and 171 entitled the Highway Traffic Regulation Act, is adopted by reference and is a part of this code as if fully set forth herein. Any violation of Chapters 65B, 168, 169, or 171 is a violation of this code.

**Subd. 1.** For purposes of section 301, “private street” shall be defined as a street providing vehicular access to two or more parcels of land which is not dedicated to the public but is owned by one or more private parties. The Highway Traffic Regulation Act shall apply to private streets within Medina.

**Subd. 2.** For purposes of this Chapter, the definitions in Minnesota Statutes, Chapter 169 shall be used whenever two or more sections of the Highway Traffic Regulation Act contain conflicting or inconsistent definitions.

**Section 301.03. Motor Vehicle Registration.** Minnesota Statutes, Chapter 168 entitled Motor Vehicles; Registration, Taxation; Sales; Dealers, is adopted by reference and is a part of this code as if fully set forth herein. Any violation of Chapter 168 is a violation of this code.

**Section 301.05. Drivers’ Licenses.** Minnesota Statutes, Chapter 171 entitled Drivers’ Licenses and Training Schools, is adopted by reference and is a part of this code as if fully set forth herein. Any violation of Chapter 171 is a violation of this code.

**Section 301.07. Recreational Motor Vehicles; Definitions.** The following words and phrases shall have the meanings ascribed to them.

**Subd. 1. Recreational Motor Vehicle** is any motorized, self-propelled vehicle designed or used for recreational purposes, including without limitation, all-terrain vehicles, trail bikes, motorcycles, and motorized bicycles, but excluding snowmobiles.

**Subd. 2. Public Lands** are lands which include, without limitation, parks and school grounds, frozen lakes, recreational areas, streets, sidewalks, public easements, golf courses, trailways, cemeteries, and other similar areas.

**Section 301.09. Trespass Prohibited.** No person shall operate a recreational motor vehicle, motorcycle, motorized bicycle, or any other motor vehicle licensed by Minnesota for travel on the public highways upon, or enter therewith upon any public or private lands within Medina without the prior written consent of the owner thereof.

**Section 301.11. Certain Conduct Prohibited.** No person shall operate any of the vehicles listed in Section 301.09:

**Subd. 1.** While under the influence of alcohol or any controlled substances as defined by Minnesota Statutes;

**Subd. 2.** At a speed which is not reasonable under the circumstances existing within the area of travel;

**Subd. 3.** In a manner which endangers or is likely to endanger a person or property, including the recreational motor vehicle and the operator and passengers thereof;

**Subd. 4.** In any manner which creates dust, noise, fumes or other dangers which disturb the peace of any person; or

**Subd. 5.** Upon any public or private lands which have not been specifically designated for vehicular travel.
