

CHAPTER 4

ROADS

425. STREET NAMES.

Section 425.01. Definitions. For the purpose of this Ordinance, the following phrases shall have the meaning given herein:

Subd. 1. The term existing street name shall, when used in this Ordinance, mean the name by which a street, avenue or public way or any part thereof is most commonly known or designated.

Subd. 2. The term new street name shall, when used in this Ordinance in connection with a stated existing street name, mean the name by which said street, avenue or public way shall be known from and after the effective date of this Ordinance.

Section 425.03. New Street Names. Existing street names are hereby changed and renamed in accordance with the following tabulation which shall be a part of this Section 425:

Section 425.05. Future Streets, Avenues and Public Ways. Names of future streets, avenues and public ways in the City of Medina shall insofar as possible conform to the pattern of this Ordinance. The pattern of this Ordinance is to designate all streets, avenues and public ways running generally North and South as "drives," The pattern of this Ordinance is to designate all streets, avenues and public ways running generally East and West as "roads." The pattern of this Ordinance is to designate all streets; avenues and public ways which are running generally in a winding and/or diagonal direction as "trails."

Section 425.07. Plan for Numbering of Properties.

Subd. 1. Except as hereinafter provided, a grid of Eight Hundred (800) per mile is hereby established throughout the entire City of Medina. The east to west grid numbering shall commence at zero at the east boundary line of the City of Medina and terminate at 4,800 at the west boundary line of the City of Medina. The south to north grid numbering shall commence at 1,200 at the south boundary line of the City of Medina and shall terminate at 4,800 at the north boundary line of the City of Medina.

Subd. 2. Brockton Lane and Highway No. 101, which are public ways common to the City of Plymouth and the City of Medina, shall be an exception to the above described grid within the City of Medina, and the numbering of these public ways shall be made to correspond with the numbering on these public ways by the City of Plymouth.

Section 425.09. Numbering of Properties.

Subd. 1. The City Council shall, upon or after the effective date of this Ordinance, appoint an official of the City of Medina to assign numbers to the several properties within the City of Medina in accordance with the plan set out in this Ordinance and for all future properties as their numbering shall become necessary. The assignment of numbers on East-West streets coming from the City of Plymouth shall be in accordance with the grid plan described herein, but in no case shall a number assigned to the City of Medina duplicate a number assigned on the same street in the City of Plymouth.

Subd. 2. The City Clerk-Treasurer shall prepare and keep as a part of the permanent records of the City a record of all numbered properties so assigned, such record to be opened for inspection by the public at all reasonable hours.

Section 425.11. Location of Property Numbers. Each owner and each occupant of a house or commercial building in the City of Medina shall place in a location in conformance with this section property address numbers of identification in accordance with the following:

Subd. 1. Property numbers or identification shall be placed so to be directly and conveniently visible from public access to the house or building.

Subd. 2. Property numbers or identification shall be placed on or above the front door of any house or building if the front door of such house or building is clearly visible from the public right-of-way.

Subd. 3. In the case of a house or building located in such manner that the front door of the house or building is not clearly visible from the public right-of-way, property numbers or identification shall be placed near the intersection of the driveway or road serving the house or building and the public right-of-way at a location clearly visible from the public right-of-way.

Section 425.13. Private Roads. In the case of two or more houses or buildings sharing a single driveway or road for purposes of egress and ingress:

Subd. 1. If the front doors of the houses or buildings are not visible from the public right-of-way, property numbers or identification of all houses and buildings served by the driveway or private road shall be placed near the intersection of the driveway or private road and the public right-of-way at a location clearly visible from the public right-of-way and at one of the additional locations:

- (a) The front door of the house or building is such house or building is clearly visible from the point where the driveway or private road divides to serve the various houses or buildings; or
- (b) The location where the driveway or private road divides to serve the various houses or buildings.

Section 425.15. Address Identification Materials. Address numerals or identification shall be constructed of durable material and shall be of contrasting color to the base to which they are attached.

Section 425.17. Duties of Police Chief; Enforcement. It is the duty of the Chief of Police or his designated authority to enforce this section. The Chief of Police shall give the owner or occupant of any house or building which does not conform with this section 15 days written notice within which to comply with the terms thereof.
