

# CONCEPT PLAN FOR TOM & JIM DITTER

IN THE EAST HALF OF THE NE 1/4 OF SECTION 24-118-23 HENNEPIN COUNTY, MINNESOTA

## LEGAL DESCRIPTION OF PREMISES

That part of the East half of the Northeast Quarter of Section 24, Township 118 North, Range 23 West of the 5th Principal Meridian, described as follows: Commencing at the Northeast corner of said East half of the Northeast Quarter; thence on an assumed bearing of South 0 degrees 00 minutes 26 seconds West along the East line of said East half of the Northeast Quarter a distance of 636.25 feet to the point of beginning of the property being described; thence South 46 degrees 09 minutes 59 seconds West a distance of 456.22 feet; thence South 36 degrees 09 minutes 34 seconds West a distance of 679.91 feet; thence South 89 degrees 59 minutes 34 seconds East to its intersection with said East line; thence northerly along said East line to the point of beginning.

That part of the East half of the Northeast Quarter of Section 24, Township 118 North, Range 23 West of the 5th Principal Meridian, described as follows: Commencing at the Northeast corner of said East half of the Northeast Quarter; thence on an assumed bearing of South 0 degrees 00 minutes 26 seconds West along the East line of said East half of the Northeast Quarter a distance of 636.25 feet; thence South 46 degrees 09 minutes 59 seconds West a distance of 456.22 feet; thence South 36 degrees 09 minutes 34 seconds West a distance of 679.91 feet to the point of beginning of the property being described; thence South 36 degrees 09 minutes 34 seconds West a distance of 211.46 feet; thence South 54 degrees 30 minutes East a distance of 488.73 feet; thence Southeasterly to a point on said East line distance 431.20 feet portherly as measured along said East line from the south point on said East line distance 431.20 feet northerly, as measured along said East line, from the southeast corner of said East half of the Northeast Quarter; thence northerly along said East line to its intersection with a line drawn on a bearing of South 89 degrees 59 minutes 34 seconds East from the point of beginning; thence North 89 degrees 59 minutes 34 seconds West to the point of beginning.

That part of the East half of the Northeast Quarter of Section 24, Township 118 North, Range 23 West of the 5th Principal Meridian, described as follows: Commencing at the Northeast corner of said East half of the Northeast Quarter; thence on an assumed bearing of South 0 degrees 00 minutes 26 seconds West along the East line of said East half of the Northeast Quarter a distance of 636.25 feet; thence South 46 degrees 09 minutes 59 seconds West a distance of 456.22 feet; thence South 36 degrees 09 minutes 34 seconds West a distance of 891.37 feet to "Point A" and the point of beginning of the property being described; thence South 36 degrees 09 minutes 34 seconds West a distance of 178.88 feet; thence South 54 degrees 30 minutes 07 seconds East a distance of 115.60 feet; thence South 36 degrees 09 minutes 34 seconds West a distance of 297.02 feet; thence South 47 degrees 51 minutes East a distance of 98.07 feet; thence South 65 degrees 07 minutes 30 seconds East a distance of 146.91 feet; thence North 89 degrees 05 minutes East a distance of 157.00 feet; thence northeasterly to a point on a line drawn on a bearing of South 54 degrees 30 minutes East a distance of 488.73 feet from said "Point A"; thence North 54 degrees 30 minutes West to the point of beginning.

That part of the East half of the Northeast Quarter of Section 24, Township 118 North, Range 23 West of the 5th Principal Meridian, described as follows: Commencing at the Northeast corner of said East half of the Northeast Quarter; thence on an assumed bearing of South 0 degrees 00 minutes 26 seconds West along the East line of said East half of the Northeast Quarter a distance of 636.25 feet; thence South 46 degrees 09 minutes 59 seconds West a distance of 456.22 feet; thence South 36 degrees 09 minutes 34 seconds West a distance of 891.37 feet to "Point A"; thence South 36 degrees 09 minutes 34 seconds West a distance of 178.88 feet; thence South 54 degrees 30 minutes 07 seconds East a distance of 115.60 feet; thence South 36 degrees 09 minutes 34 seconds West a distance of 297.02 feet to the point of beginning of the property being described; thence South 47 degrees 51 minutes East a distance of 98.07 feet; thence South 65 degrees 07 minutes 30 seconds East a distance of 146.91 feet; thence North 89 degrees 05 minutes East a distance of 157.00 feet; thence northeasterly to a point on a line drawn on a bearing of South 54 degrees 30 minutes East a distance of 488.73 feet from said "Point A"; thence Southeasterly to a point on the East line distant 431.20 feet northerly, as measured along said East line, from the Southeast corner of said East half of the Northeast Quarter; thence westerly parallel with the South line of said East half of the Northeast Quarter a distance of 600.10 feet; thence southerly parallel with the East line of said East Half a distance of 36.90 feet; thence westerly, deflecting right 91 degrees 51 minutes a distance of 340.70 feet; thence southwesterly, deflecting left 51 degrees 13 minutes to the northeasterly right of way line of Holy Name Drive; thence northwesterly along said northeasterly right of way line to its intersection with the North line of the South 412.50 feet of said East half of the Northeast Quarter; thence northerly along said West line to a point on said West line distance 452.91 feet northerly of, as measured along said West line, the Southwest corner of said East half of the Northeast Quarter; thence easterly parallel with said South line a distance of 84.32 feet; thence North 79 degrees 20 minutes East to its intersection with a line drawn on a bearing of South 42 degrees 39 minutes 34 seconds West from the point of beginning; thence North 42 degrees 39 minutes 34 seconds East to the point of beginning.
